Welcome to 2012. I hope during the December holidays you were able to spend more time with family and friends. Thankfully, I was able to connect with several relatives and friends that I had not seen in a while.

Recalling our December 11<sup>th</sup> meeting, **I wish to thank Mona and Abed Hammoud for hosting our gathering.** I also thank everyone for contributing to our feast. Abed provided us a glimpse of the work he is doing as a U.S. District Assistant Prosecuting Attorney. The unit covers white collar crime, bank fraud, investment fraud (especially against senior citizens). Abed helped draft new laws applying to mortgage fraud, forgery, real estate documents, notary laws, and extending statute of limitations.

Our League calendar is filling with activities for this New Year, especially Voter Service tasks. Meetings are taking place to update our **Who's Who of elected officials for 2012.** Next, we will be learning how to utilize a voter service tool developed by LWVUS called **VOTE 411.** The web-based system promises to be an effective way of collecting candidate and voter related information. Our Michigan league has purchased the system and is extending permission to use it to all local leagues.

We applied for and received a LWVUS grant to conduct an energetic **Youth Registration Project.** Barbara Adams initiated the application and Betsy Cushman and Joe Borrajo agreed to help lead the process. Other helpers are: Mary Bugeia, Judy Carty, Dennis Kirchoff, Judy Patrick, and Chris Sullivan, who will be contacting area high school principals to arrange registration events.

Our main meeting this month will be **Saturday, January 21, at 9:30 am,** in the lounge of Christ Episcopal Church to conduct **National Program Planning.** This is an opportunity to re-acquaint ourselves with established LWVUS positions. We will review the various positions and discuss their relevance today. You may decide to initiate advocacy or recommend updating a position, or suggest a new study. We recently completed "The Federal Role in Public Education" and are in the midst of studying "Privatization of Public Services". ***So, please plan to attend and join in this important discussion.***

Judy Patrick will be holding a meeting at 2pm, on January 24<sup>th</sup>, to consider ways to increase our fundraising efforts. You are welcome to join us in the office to share ideas, or call Judy (313-563-4334) to make suggestions.

## Contracts, Deals, Layoffs, Cuts! Privatization Round 2

If you've been following the trend, you might have read articles about building/property sales, job losses and business contracts to handle public services. Consider the potential benefits and perils of privatization at our **"Hot Topic" Roundtable on February 11<sup>th</sup>**.

All levels of government are under pressure to cut down on services as a cost-saving measure, or simply on principle. What have you noticed? What difference does it make?

Our November Roundtable gave us a good start, but now we need to pin down some specifics on this topic. What is the proper role for the private sector? What concerns do you have about oversight and corruption? After the public system has been dismantled, will the public be vulnerable if the provider falters or jumps ship? What can we learn from existing successes and failures? Join us for a guided discussion.

We want to notify you that the LWVDC (Washington, D.C.) will sponsor the following proposal for concurrence at Convention 2012 in June:

"Sentencing Policy

(1) The LWVUS believes alternatives to imprisonment should be explored and utilized, taking into consideration the circumstances and nature of the crime.

(2) The LWVUS opposes mandatory minimum sentences for drug offenses."

A study published this month has revealed that up to 41% of young people in the United States have been arrested by age 23 for something other than minor traffic violations. The United States is the largest jailer of citizens per capita in the world, with enormous economic and social costs. Much imprisonment is due to harsh mandatory minimum sentences for drug offenses. After imprisonment, having a criminal record carries a lifetime of daunting obstacles to succeed as a productive citizen.

**It Happens Here – Human Trafficking and Sexual Exploitation**

Kathy Gapa reported on the LWV Oakland Area Event for this article.

*Theresa Flores was 15, living in Birmingham, MI when she became trapped in a sex-slave operation for two years. "It happens here," Flores says, "to white, middle-class teens who live in the suburbs. It's easy to think that because you live in a nice neighborhood, you're safe."*

Flores was on the track team, had a nice house and seemed like an ordinary suburban girl, but at night, she was subjected to horrendous abuse. Compelled to keep her secret to protect her family from a scandal, she snuck out of the house - in compliance but against her will. This started with a crush in high school. Taking advantage of her affection, a 16 year old boy brought her to his house and raped her while others photographed the incident. The photos were used to blackmail her into cooperating, coerced into becoming a sex slave for the benefit of a criminal enterprise. She was finally free when her family moved, still unaware of her trauma.

Theresa Flores' story is typical of sex-trafficking victims that Nicole McGee, Special Victims Agent, FBI-Michigan deals with daily. Agent McGee spoke on October 17 for the LWVOA about the worldwide problem of human trafficking, including its prevalence within the United States. 40% of all forced labor-human trafficking...

**Find out about YOUR Drinking Water**

Along with speaker Professor Xi, an assistant professor of environmental health sciences at UM, we will be discussing our regional water supplier, DWSD. Did you know that this department is a not-for-profit entity? Rates are based on cost of service only, with no other source of revenue. DWSD has more than 2000 employees.

Detroit Water and Sewerage Department, a part of the City of Detroit, is governed by 7 Commissioners, appointed by the Mayor. Four represent Detroit Residents and three represent municipalities outside of Detroit.

*"Today, DWSD provides water service to almost one million people in Detroit and three million people in 126 neighboring Southeastern Michigan communities throughout Wayne, Oakland, Macomb St. Clair, Lapeer, Genesee, Washtenaw and Monroe counties."* [http://www.dwsd.org/pages\\_n/about\\_dwsd.html](http://www.dwsd.org/pages_n/about_dwsd.html)

### **Opinion by Joe Borrajo – Privatization**

The cachet of "privatizing services" is it saves money, but is that true? In the mid 1990s, Dearborn sought to save money by erecting the Yule-tide decorations on city hall grounds through a contractor instead of employees. Cost: \$50,000.00. Turns out the contractor sent a single worker to supervise the same city employees that weren't suppose to be used for the task of decorating the grounds. The task took a matter of a few days, but \$50,000.00 could've paid the salary of an employee for a year.

Besides the money proposition, "privatization" also raises the question of the quality of services rendered. The process of out-sourcing responsibilities can lead to the problem of inferior work requiring remedial effort that translates into cost-overruns, left for the taxpayer to cover. Likewise, communities can be expected to accommodate "privatization's" development with a costly infrastructure and upgrading that explicitly serves the recipient of the community's asset with little return to the taxpayer.

Furthermore, the subject of "privatization" rarely broaches the matter of community/taxpayer "assets". Putting valuable assets, a measure of the wealth and value of a community, into the hands of corporation developers and speculators is a forfeiture that weakens the very foundation of a community, leaving it open to having the quality of life negatively impacted. "Privatization" can leave a mark comparable to what the problematic issue of "eminent domain" has done to injure stable residential communities.

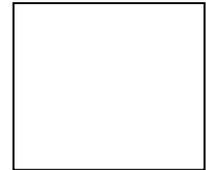
