Dearborn Heights Public Schools

Most of Dearborn Heights is in 4 school districts: Crestwood, Dearborn, District 7 and Westwood. Small sections of Dearborn Heights are in the Taylor and Wayne-Westland school districts.

Inkster Public Schools

Inkster has 4 school districts – Taylor, Westwood, Wayne-Westland and Romulus.

Dearborn Public Schools

All of Dearborn is in the Dearborn School District.

Public charter schools have no publicly elected school boards and are not included in this list.

HOW TO CONTACT LEGISLATORS

Your opinion on how your city, county, state and federal government is run can make a difference. Your input – a phone call, an email, or a letter – is heard. Most citizens don't take the time to contact their legislators. Those who do can influence the vote!

For best results:

- **Visit your legislator in person. Make a phone call. Write a personal email.** Use your own words. On-line petitions are better than no contact at all but legislators say they really pay more attention when they hear directly from citizens in person (look for a coffee hour near you, or go to visit them in their office), or receive a message that their constituents phoned or emailed.
- **Phone calls and emails are faster and more efficient than letters.** Security considerations delay letters. Some legislators have toll-free phone numbers.
- **Make your contact when the bill is still in committee, before it is voted on.** Identify the bill by number. Legislators are working on dozens of bills at the same time.
- **Always identify yourself and your address.** Include your return address in your email or letter. If you phone, volunteer your name and address. Anonymous contacts go nowhere.
- **Be brief but state reasons for your opinion.** Be constructive and ask for a response. Courtesy is far more effective than a "rant." Share something personal about your background or experience. For example, "I have been a teacher for 20 years" or "I work in road construction" and I urge you to vote yes (or no) on H.B.____.
- **Thank them for their time.**

How to address the official in your email or letter:

- On the envelope, "The Honorable ____" (true for all elected officials)
- In the email or letter, "Dear Senator ____" or "Dear Representative ____" or "Dear Commissioner ____" or "Councilman/woman ____"

VOTING BASICS

- Only registered voters may vote.
- You must show photo identification or sign an affidavit.
- To register to vote, or to make sure you are registered, go on-line:
www.michigan.gov/sos

TO VOTE, YOU MUST BE:

- Registered to vote at least 30 days before the election.
- U.S. citizen, at least 18 years old by Election Day.
- Resident of Michigan and your city

ABSENTEE BALLOTS

Requests for absentee ballots must be made in writing to your city clerk no later than 2 p.m. the Saturday before the election. You may request an absent voter ballot if you are:

- Age 60 years or older.
- Unable to vote without assistance at the polls.
- Expecting to be out of town on election day.
- In jail awaiting arraignment or trial.
- Unable to attend the polls due to religious reasons.
- Appointed to work as an election inspector in a precinct outside of your precinct of residence.

*Absentee ballots must be in City Clerk's office by close of polls (8:00 p.m.)
on Election Day.*
